Effective July 1, 2020 our Funds Availability policy will be changed to the following:

We are increasing the amount we make available for withdrawal by the next business day, on checks deposited and not subject to next day availability from \$200 to \$225. In addition, the amount available for withdrawal on exception holds for large deposits, and the threshold for determining a repeat overdraft increases from \$5,000 to \$5,525.
